## **OUIT CLAIM DEED**

The South Half (½) of the Southwest Quarter (¼) and the Southwest Quarter (¼) of the Southeast Quarter (1/4) of Section Fourteen (14), and in the Northwest Quarter (1/4) of the Northeast Quarter (1/4) and the Northeast Quarter (1/4) of the Northwest Quarter (1/4) of Section Twenty-three (23), ALL in Township Seventysix (76) North, Range Twenty-seven (27) West of the 5th P.M., Madison County. Iowa: EXCEPT Lots Fifteen (15) and Sixteen (16) in the Quail Ridge Subdivision, located in the South Half ( $\frac{1}{2}$ ) of the Southwest Ouarter ( $\frac{1}{4}$ ) and the Southwest Quarter (1/4) of the Southeast Quarter (1/4) of said Section Fourteen (14).

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.
