

LEGAL DESCRIPTION:

PARCEL 2021—105, Part of the Southwest Quarter (SW1/4) of the Southeast Quarter (SE1/4) of Section Twenty—Four (24), Township Eighty—Eight North (T88N), Range Five West (R5W) of the Fifth Principal Meridian, Delaware County, Iowa, part of the Road Area of Camp—O Delhi as recorded in Book 5 of Plats, Page 78 in the Office of the Delaware County Recorder, containing a total area of 0.010 acres, subject to easements whether of record or not of record and more specifically described by metes and bounds as follows:

Commencing at the Northwesterly corner of Lot Sixty—Seven (67) of Camp—O—Delhi as recorded in Book 5 of Plats, Page 78 in the Office of the Delaware County Recorder, this also being the Point of Beginning (POB);

Thence North 34'33'23" East along the East line of Parcel V as recorded in Book 2007, Page 665 in the Office of the Delaware County Recorder, a distance of 12.99 feet to the Southwesterly corner of Lot 66 of Camp—O—Delhi;

Thence South 78'42'39" East along the Southerly line of said Lot 66, a distance of 29.72 feet;

Thence South 04.58'06" West, a distance of 12.00 feet to the Northeasterly corner of Lot 67 of Camp-O-Delhi;

Commencing at the Northeasterly corner of Parcel V as recorded in Book 2007, Page 665 in the Office of the Delaware County Recorder, also being a point on the East—West 1/4, 1/4 Section line in the SE1/4 of Section 24, T88N, R5W, also being the Point of Beginning (POB);

Thence South 04'58'07" West, a distance of 55.29 feet to the North line of the Road Area of Camp—O Delhi as recorded in Book 5 of Plats, Page 78 in the Office of the Delaware County Recorder;

Thence North 78°42'39" West along the North line of said Road Area, a distance of 29.72 feet, to the East line of said Parcel V,

Thence North 34'33'23" East along the East line of said Parcel V, a distance of 59.82 feet to the POB.

Commencing at the Northeasterly corner of Parcel V as recorded in Book 2007, Page 665 in the Office of the Delaware County Recorder, also being a point on the East—West 1/4, 1/4 Section line in the SE1/4 of Section 24, T88N, R5W, also being the Point of Beginning (POB);

Thence North 88°31'07" East along said 1/4, 1/4 Section Line, a distance of 65.25 feet to the Westerly Lot line of Lot 65 of Camp—O Delhi.

Thence South 00°42'57" East along the Westerly line of Said Lot 65, a distance of 70.93 feet to the North line of a Road Area in Camp—O—Delhi,

Thence North 78'42'39" West along said North line of said Road Area, a distance of 72.30 feet;

Thence North 0458'07" East, a distance of 55.29 feet to the POB;
