I, John Francois, being first duly sworn on oath, depose and state as follows:

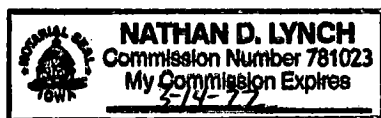
1. Lois C. Francois is the surviving spouse of Leo J. Francois, who died on February 3, 2022, at Manchester, Delaware County, Iowa.


