ASSIGNMENT OF PERMANENT SANITARY SEWER EASEMENT AND TEMPORARY CONSTRUCTION EASEMENT

THIS AGREEMENT made and entered into by and between Delaware County, Iowa (hereinafter "ASSIGNOR") and Eastern Iowa Regional Utility Services System (hereinafter "ASSIGNEE").

FOR THE PARTIES' JOINT AND MUTUAL CONSIDERATION IT IS HEREBY AGREED AS FOLLOWS THAT:

- 1. THE UNDERSIGNED ASSIGNOR states that the ASSIGNOR lawfully acquired a permanent sanitary sewer easement and temporary construction easement (hereinafter collectively referred to as "EASEMENT") by eminent domain, filed January 10, 2022, as Book 2022, Page 106, of the records of Delaware County, Iowa. ASSIGNOR has the lawful right to assign the EASEMENT described herein.
- 2. Said EASEMENT lies within Westside Street of Mormann Subdivision, as recorded in Plat Book 2, Page 60, Delaware county, Iowa, more particularly described as follows;

Beginning at the Southwest Corner of Said Westside Street; thence North 03 Degrees, 31 minutes, 06 seconds East along the West line of said Westside Street, 549.38 feet to the North line of said Westside Street; thence North 86 degrees, 17 minutes, 15 seconds East along said North line, 34.97 feet; thence South 46 degrees, 53 minutes, 05 seconds West, 21.39 feet; thence South 03 degrees, 31 minutes, 06 seconds West, 537.00 feet to the South line of said Westside Street; thence North 89 degrees, 59 minutes, 37 seconds West along said South line, 20.04 feet to the point of beginning.

3. Said EASEMENT provides:

- A. An exclusive permanent public utility easement for the purposes of constructing, operating, maintaining, repairing, using, and reconstructing a sanitary sewer main.
- B. An exclusive temporary construction easement for the purpose of constructing the Project, which shall terminate and become nonexistent after the construction is fully completed.
- C. The right to make excavations and to grade as it may reasonable be necessary for the construction, installation, operation, repair, maintenance, and reconstruction of the sanitary sewer main in the permanent easement area.
- D. The right to trim and remove all trees and bushes which may interfere with Applicant's use of the easement.
- 4. The ASSIGNOR does hereby assign, transfer, and convey to the ASSIGNEE, all of ASSIGNOR'S title, right, obligations, and interest in the EASEMENT.
- 5. ASSIGNEE agrees by acceptance and recordation of this Assignment of Easement, that those terms and conditions set forth in the EASEMENT shall be binding upon ASSIGNEE. The ASSIGNEE hereby assumes all of ASSIGNOR'S obligations and duties relating to the EASEMENT.
- 6. The provisions hereof shall inure to the benefit of and bind the heirs, successors, personal representatives and assigns of the respective parties hereto, and all covenants shall apply to and run with the land.
- 7. The ASSIGNOR'S compensation for this assignment of easement, is \$1.00, to be paid in full at time of signing and ASSIGNOR hereby confirms receipt of said payment in full.
