ASSIGNMENT AND ASSUMPTION OF GROUND LEASE

THIS ASSIGNMENT AND ASSUMPTION OF GROUND LEASE (this "Assignment") is entered into as of this 1st day of March, 2022 (the "Transfer Date"), by and by and between FTC Tower Co., LLC, a South Carolina limited liability company, having an address at 1101 E. Main Street, Kingstree, South

Carolina 29556 ("<u>Assignor</u>"), and **Vertical Bridge Development, LLC**, a Delaware limited liability company, having an address at 750 Park of Commerce Dr., Suite 200, Boca Raton, Florida 33487 ("<u>Assignee</u>").

WITNESETH

WHEREAS, Assignor and an Affiliate of Assignee have entered into an Asset Purchase Agreement of even date herewith (the "<u>Purchase Agreement</u>"), with capitalized terms used herein without definition having the meanings set forth therein), which provides for the purchase by Assignee from Assignor of the Purchased Assets; and

WHEREAS, the Purchase Agreement requires that Assignor assign to Assignee all of Assignor's right, title, and interest as tenant in the real property lease described on <u>Exhibit A</u> (the "<u>Lease</u>"), as evidenced by the memorandum of lease described on <u>Exhibit A</u>, and that Assignee accept such assignment and assume all of Assignor's duties, obligations, covenants and undertakings under the Lease on and after the Closing Date.

NOW, THEREFORE, in consideration of the mutual agreements and covenants hereinafter and in the Purchase Agreement set forth, and good and other valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereto agree each with the other as follows:

- 1. <u>Incorporation</u>. The "Whereas" clauses set forth above are hereby incorporated into and made part of this Assignment.
- 2. <u>Assignment of Lease</u>. Assignor does hereby sell, assign, transfer, convey, and deliver unto Assignee, its successors and assigns, all of the right, title and interest of Assignor as tenant in, to and under the Lease, effective as of the Transfer Date, TO HAVE AND TO HOLD the same unto Assignee, its successors and assigns, for and during all the rest, residue and remainder of the term of the Lease and any extensions or renewals thereof, all as set forth in the Lease, the provisions of which are by this reference thereto incorporated herein, all free and clear of Encumbrances other than Permitted Encumbrances.
- 3. <u>Acceptance and Assumption of Lease</u>. Assignee hereby accepts the assignment of the Lease and expressly assumes and covenants in favor of Assignor to pay, discharge and perform, as and when due, all obligations of Assignor under the Lease accruing, arising out of, or relating to events or occurrences on and after the Transfer Date.
- 4. <u>Indemnity</u>. The indemnification provisions contained in the Purchase Agreement are hereby incorporated by reference with respect to the Lease.
- 5. <u>Purchase Agreement Controls.</u> Nothing in this Assignment shall be deemed to expand or diminish the scope of the rights of any party to the Purchase Agreement that are contained in the Purchase Agreement. If there is conflict or an apparent conflict between the provisions of this Assignment and the provisions of the Purchase Agreement, the provisions of the Purchase Agreement shall control.
- 6. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall be deemed to be an original, but which together shall constitute one and the same instrument.
- 7. <u>Successors and Assigns</u>. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

8. <u>Further Assurances</u>. Assignor and Assignee agree that, from time to time, each of them will execute and deliver such further instruments of conveyance and transfer and take such other actions as may be reasonably necessary to carry out the purposes and intents of this Assignment and the transactions contemplated hereby.

A part of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of Section Nine (9), Township Ninety (90) North, Range Three (3) West of the Fifth Principal Meridian, Delaware County, Iowa containing 244,023 square feet (5.602 acres) of land and being described by:

Commencing at the North Quarter Corner of said Section 9; thence N88°-45'- 54"E 702.23 feet along the North line of the NE 1/4 of said Section 9;

thence S01°-14'-06"E 1809.79 feet to the point of beginning;

thence \$53°-03'-38"E 500.00 feet;

thence S36°-56'-22"W 500.00 feet;

thence N53°- 03'-38"W 381.18 feet to point on the Easterly Right of Way line of Highway 3;

thence N12°- 48'-06"W (recorded as S11°-37'E) 155.70 feet along said Easterly Right of Way line;

thence N36°-56' -22"E 399.38 feet to the point of beginning,

being subject to any and all easements and restrictions of record.

30' WIDE UTILITY & INGRESS/EGRESS EASEMENT:

A part of the Southwest Quarter (SW 1/4) of the Northeast Quarter (NE 1/4) of Section Nine (9), Township Ninety (90) North, Range Three (3) West of the Fifth Principal Meridian, Delaware County, Iowa containing 16,588 square feet (0.381 acres) of land and being Fifteen (15) feet each side of and parallel with the following described line:

Commencing at the North Quarter Corner of said Section 9;

thence N88°-45'- 54" E 702.23 feet along the North line of the NE 1/4 of said Section 9;

thence S01° -14'-06" E 1809.79 feet;

thence S53°-03'-38" E 302.50 feet;

thence S36°-56'-22" W 262.50 feet to the point of beginning;

thence continue S36°-56'-22" W 37.50 feet to a point herein after referred to as "Point A";

thence continue S36°- 56'-22" W 52.50 feet;

thence N53°-03'-38" W 52.50 feet to the point of termination.

Also, beginning at said "Point A", thence \$53°-03'-38" E 159.24 feet;

thence S08°-03'-38" E 38.56 feet;

thence S36°-56'-22" W 212.62 feet to a point on the North Right of Way line of 115th Street and the point of termination.

The side lot lines of said easement are to be shortened or lengthened to terminate on said north line of 115th Street.
