The North one-half (N1/2) of the Northwest Quarter (NW1/4) of Section Twenty Four (24), Township Eighty Eight (88) North, Range Six (6), West of the 5th P.M., except that part described as commencing at the Northwest corner of said Section Twenty Four (24), thence South five hundred fifteen (515.0) feet to the point of beginning, thence East three hundred one (301.0) feet, thence South three hundred one (301.0) feet, thence North three hundred one (301.0) feet to point of beginning.

Grantors do Hereby Covenant with grantees, and successors in interest, that grantors hold the real estate by title in fee simple; that they have good and lawful authority to sell and convey the real estate; that the real estate is free and clear of all liens and encumbrances except as may be above stated; and grantors Covenant to Warrant and Defend the real estate against the lawful claims of all persons except as may be above stated.
