ORDINANCE 001-2022

AN ORDINANCE VACATING THAT PORTION OF THE ALLEY DESCRIBED AS LYING BETWEEN LOTS 668, 669, 732 AND LOT 733, AND THE WEST 15 ½ FEET OF LOTS 667 AND 734, DELAWARE, IOWA, ACCORDING TO PLAT RECORDED IN BOOK 2 L.D., PAGES 488-489

BE IT ENACTED by the City Council of the City of Delaware, lowa:

SECTION 1. That portion of the alley described as lying between Lots 668, 669, 732 and Lot 733, and the West 15 ½ feet of Lots 667 and 734, Delaware, Iowa, according to plat recorded in Book 2 L.D., Pages 488-489, (locally known as: alley adjacent to 211 West Adams Street, Delaware, Iowa), is closed from public use and vacated.
