
- a. No new street or improvements are necessary at this time.

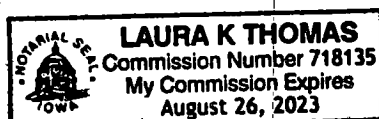


