For the consideration of One (\$1.00) Dollar and other valuable consideration, the Mary K. Fransen Farm Trust, does hereby Quit Claim a life estate to Mary K. Fransen, with the remainder interest to Ryan Gericke and Christopher Gericke as tenants in common, all its right, title, interest, estate, claim and demand in the following described real estate in Delaware County, Iowa:

The East ninety two (92) acres of the Southwest fractional Quarter (SW 1/4) of Section Six (6); and the Northwest Quarter (NW 1/4) of the Northeast Quarter (NE 1/4) except that part described as commencing at a point eight hundred thirty one (831.0) feet East of the Northwest corner of said Northeast Quarter (NE 1/4), thence East two hundred eighteen and five-tenths (218.5) feet along the North line of said Northeast Quarter (NE 1/4), thence South 1° 42' West one hundred fifty five (155.0) feet, thence West one hundred fourteen and five tenths (114.5) feet, thence North 1° 42' East sixty five (65.0) feet, thence West one hundred four (104.0) feet, thence North 1° 42' East Ninety (90.0) feet to the point of beginning; and the West nine and twenty seven-thirty seconds (9 27/32) acres of the North nine-sixteenths (N9/16) of the East one-half (E 1/2) of the Northeast Quarter (NE 1/4); and commencing eighty (80.0) rods East of the Northwest corner of Section Seven (7), thence East ninety one and seventy three one-hundredths (91.73) rods, thence South far enough to make fifty one and seventy three one-hundredths (51.73) acres, thence West ninety one and seventy three one-hundredths (91.73) rods, thence North to the point of beginning, in Section Seven (7), all in Township Ninety (90) North, Range Six (6), West of the Fifth P.M. and The West 41.06 acres of the NW 1/4 of the fractional NW 1/4 of Section 7-90-6.

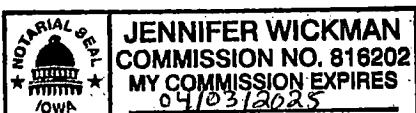

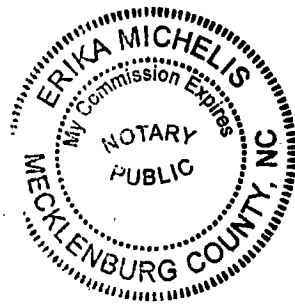
