For the consideration of Ten Dollar(s) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ORBIS CORPORATION, a Wisconsin corporation (formerly known as Menasha Material Handling Corporation) ("Grantor"), does hereby sell and convey to ROGUE PARTNERS, LLC, a Minnesota limited liability company ("Grantee") the following described real estate in Delaware County, Iowa:
