AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

I, Karen A. Everett, being first duly sworn on oath, depose and state as follows:

- 1. I am the surviving spouse of Randy K. Everett, who died on August 11, 2022.,
- 2. The following described real estate was owned only by Randy K. Everett and this Affiant, as joint tenants with full rights of survivorship at the time of Randy K. Everett's death:

A parcel of land situated on the East side of the North Half (N½) of the Northeast Quarter (NE¼) of Section One (1), Township Ninety (90) North, Range Five (5), West of the Fifth Principal Meridian, described as beginning at a point in the center of cement slab on Iowa Highway #3 East of the dwelling situated on said above described premises, said beginning point being seventy seven and one half (77½) feet East of the Southeast corner of concrete foundation of said dwelling and fifty three (53) feet South thereof; from said beginning point, thence West one hundred sixty (160) feet on a line parallel with the South side of said dwelling foundation wall; thence North one hundred eighty nine (189) feet; thence East parallel with the said South line one hundred forty five (145) feet to center of paved highway, thence along center of said highway to point of beginning,

- 5. Form 706, United States Estate Tax return, **IS NOT** required to be filed as a result of the death of the Decedent.


6. An Iowa inheritance tax return is not required to be filed pursuant to Iowa Code Section 450.22 subsection 3.
