QUIT CLAIM DEED

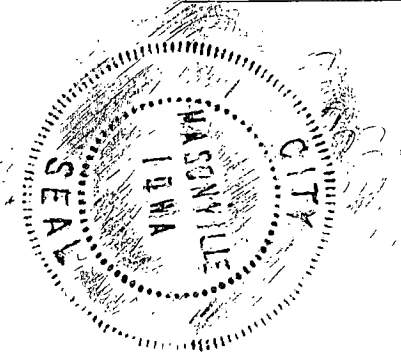
For the consideration of One Dollar(s) and other valuable consideration, City of Masonville, Iowa, an Iowa Municipal Corporation, organized and existing under the laws of Iowa, does hereby Convey to Patrick L. Loughren, husband and wife, as joint tenants with rights of survivorship and not as tenants in common all our right, title, interest, estate, claim and demand in the following described real estate in Delaware County, Iowa:
