2. The City of Masonville shall retain any and all existing easements for utilities, and necessary maintenance of said utilities.

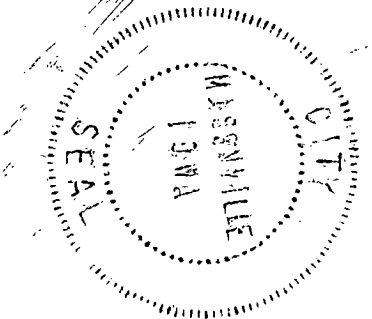

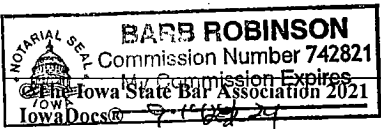
