QUIT CLAIM DEED

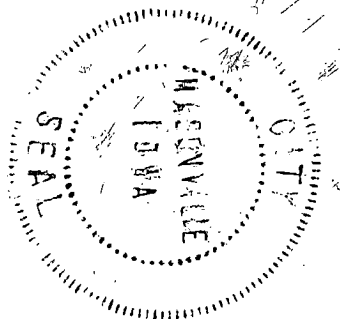

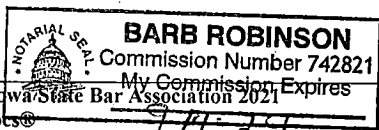
