QUIT CLAIM DEED

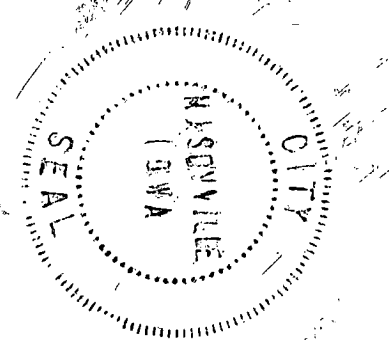

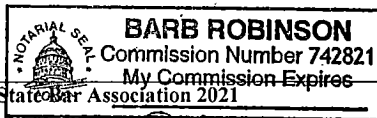
