Pursuant to the authority and power vested in the undersigned, and in consideration of Ten Dollar(s) and other valuable consideration, the undersigned, in the representative capacity designated below, hereby Convey(s) to Richard D. Bishop, the following described real estate in Delaware County, Iowa:

The East One-Half of the Northeast Quarter of Section 18, except a railroad right-of-way, Township 88 North, Range 5, West of the 5th P.M.

AND

The West One-Half to the Northwest Quarter of Section 17, Township 88 North, Range 5, West of the 5th P.M., except the North 500 feet of the East 550 feet of the Northwest Quarter of the Northwest Quarter of said Section 17.

AND
