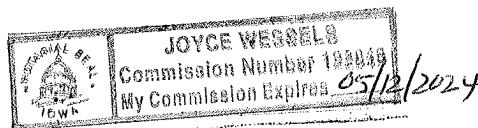
2. I am the presently existing Trustee under the Trust and I am authorized to convey without any limitation or qualification whatsoever.
