NOW, THEREFORE, Tenant hereby sets forth the following information with respect to the Lease:


1. The name of the landlord is Renee Conley.

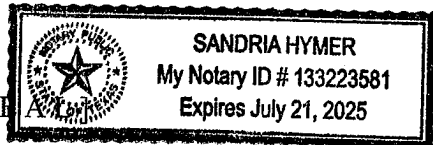
