Niehaus Revocable Trust dated March 18, 2015, does hereby Convey to Nicole L. Ries, as a single person, the following described real estate in Delaware County, Iowa:

An undivided one-half (1/2) interest in Lot Twenty Six (26) of Oakview Estates First Subdivision A Subdivision of Part of the NE¼ of the SW¼ Section 33, T89N, R5W of the Fifth P.M., City of Manchester, Delaware County, Iowa, according to plat recorded in Book 2022, Page 2892.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.
