VERIFIED CLAIM IN RE WESTRIDGE ESTATES 6TH ADDITION

Lots 1 thru 27 of Westridge Estates 6th Addition, City of Dyersville, Iowa, per Plat recorded Re: in Book 2009, page 2910.

We, the undersigned, being first duly sworn or affirmed, state the following statements are true as the undersigned verily believes:

- 1. There was filed in the office of the Recorder of Delaware County, Iowa, on October 22, 2009, and recorded in Book 2009, page 3976, a General Declaration of Covenants and Restrictions governing property generally described as Westridge Estates 6th Addition and as more specifically described therein. Said covenants, conditions and restrictions governing the use of the lots within said subdivision were for the mutual benefit of all owners of said lots for a period of time until September 1, 2023, at which time the covenants will be automatically extended for successive periods of ten (10) years, unless by vote of the majority of then owners of the lots, it is agreed to change the covenants in whole or in part.
