LIMITED POWER OF ATTORNEY

KNOW ALL PERSONS BY THESE PRESENTS:

THAT, BANK OF AMERICA, N.A. ("BANA"),¹ a national banking association located at 450 American St., Simi Valley, CA, 93065, First American Title Insurance Company, a Nebraska corporation and First American Mortgage Solutions, LLC, a Delaware limited liability company (collectively "Vendor") located at 3 First American Way, Santa Ana, California 92707, are parties to that certain Assignment Services Statement of Work and that certain Reconveyance/Release – Reinstatement of Lien Services Statement of Work (the "SOWs"). In furtherance of certain responsibilities BANA has outsourced to Vendor under SOW, BANA does hereby make, constitute, and appoint each of the Vendor's duly authorized Vice Presidents as an Attorney-in-Fact for BANA (each an "Attorney-in-Fact"), acting for BANA and in BANA's name, place and stead, for BANA's use and benefit, to bind BANA by each of his/her execution of those documents related specifically to the following:

1. Execute or file assignments of mortgages or of any beneficial interest in a Mortgage;
2. Execute or file reconveyances, deeds of reconveyance or releases or satisfactions of mortgage or similar instruments releasing the lien of a Mortgage and rescissions or other instruments necessary to reinstate the lien of a mortgage.

Any documents executed by an Attorney-in-Fact in accordance with this Limited Power of Attorney shall fully bind and commit BANA and all other persons or entities may rely upon the execution thereof by the Attorney-in-Fact as if executed by BANA and as the true and lawful act of BANA.

All previous acts by an Attorney-in-Fact done in the proper and lawful exercise or purported exercise of all or any of the powers, authorities and discretions included herein are hereby ratified and confirmed with the same force and effects as if such acts had been done after the execution and delivery of this Limited Power of Attorney.

This Limited Power of Attorney shall expire upon the earlier of (i) such Attorney-in-Fact's resignation or termination from Vendor, (ii) such Attorney-in-Fact's realignment to another role within Vendor that

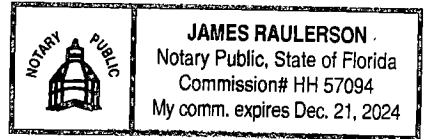
