## <u>Limited Power of Attorney</u> for Substitutions of Trustee and Mortgage Releases

BMO Harris Bank N.A., a national banking association ("Servicer") with a business address of 320 S. Canal St. Chicago, IL 60606, does hereby make, appoint, and authorize First American Mortgage Solutions, LLC, a Delaware limited liability company ("Vendor"), with a business address of 3 First American Way, Santa Ana, CA 92707, to be Servicer's true and lawful attorney-in-fact and hereby grants Vendor authority and power to take, through its duly-appointed and authorized Representatives (defined below), the following actions in Servicer's name, place and stead with respect to each mortgage loan and home equity loan or home equity line of credit (the "Mortgage Loans") owned and/or serviced by Servicer and referred to Vendor for processing:

- Substitutions of Trustee: The power and authority to execute Substitutions of Trustee on behalf of Servicer (in Servicer's name) where Servicer, in its capacity as Beneficiary under deeds of trust (or trust deeds) securing the Mortgage Loans is appointing a new trustee under the deeds of trust (or trust deeds) ("Substitutions of Trustee"); and
- 2) Mortgage Releases: The power and authority to execute Releases of Mortgage, Deeds of Release, or similar documents on behalf of Servicer (in Servicer's name) as Mortgagee, Lender, or Grantee (as applicable) under mortgages, security deeds, or similar documents securing the Mortgage Loans, as requested to do so by Servicer ("Mortgage Releases").

Servicer gives said attorney-in-fact full power and authority to execute said Substitutions of Trustee and Mortgage Releases and to do and perform all and every act and thing requisite, necessary, and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully, to all intents and purposes, as Servicer itself might or could do, and Servicer hereby does ratify and confirm all that Vendor as Servicer's attorney-in-fact shall lawfully do or cause to be done under the limited authority granted herein.

Immediately Effective; Expiration. This Limited Power of Attorney and the terms herein are effective immediately upon the Effective Date (defined below), and shall not terminate until revoked in writing by Servicer.

<u>Vendor's Authorized Representatives</u>. This Limited Power of Attorney may only be used in the execution of the powers herein by (a) those Vendor officers who have been duly appointed as Executive Vice President, Senior Vice President, Vice President, Assistant Vice President, Secretary or Assistant Secretary; and (b) non-officers who have been duly designated by Vendor as having signing authority for the tasks listed above ("Representatives").

The undersigned, John Crandall, being a Director of BMO Harris Bank N.A., a national banking association, is a duly authorized corporate officer and is authorized to grant this power of attorney on behalf of BMO Harris Bank N.A. on this 27 Hz day of January, 2023 ("Effective Date").
