### TRUSTEE WARRANTY DEED

For the consideration of One Dollar(s) and other valuable consideration, Walter J. Loecke and Kay E. Loecke, Trustees of the Walter & Kay Loecke Trust, hereby Convey to Marilyn A. Atkinson, single, the following described real estate in Clayton County, Iowa:

Lot Eight (8) of Grayson's First Subdivision, a subdivision of Lot Twelve (12) of Sun Rise Acres Addition, City of Manchester, Delaware County, Iowa, according to plat recorded in Book 3 Plats, Page 182.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.

The grantor hereby covenants with grantees, and successors in interest, that grantor holds the real estate by title in fee simple; that grantor has good and lawful authority to sell and convey the real estate; that the real estate is free and clear of all liens and encumbrances, except as may be above stated; and grantor covenants to warrant and defend the real estate against the lawful claims of all persons, except as may be above stated.
