TRUSTEE WARRANTY DEED (Inter Vivos Trust)

Kent, Trustee of the Diane E. Kent Revocable Intervivos Trust dated January 10, 2007, do hereby convey to Daniel Kimball and Sara Kimball, husband and wife, as joint tenants with full rights of survivorship and not as tenants in common, the following described real estate in Delaware County, Iowa:

Lots 6 and 6A of Lake View First Addition to Delaware County, Iowa, according to plat recorded in Book 6 Plats, Page 42.

Subject to restrictions, easements, covenants, ordinances, and limited access provisions of record.
