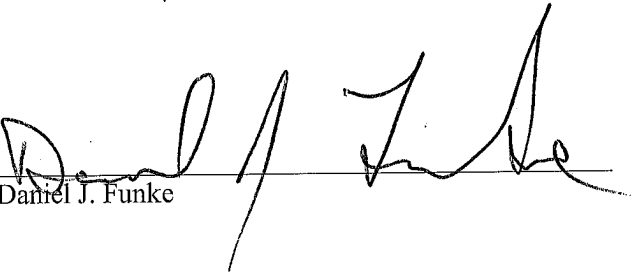
I, Daniel J. Funke, being first duly sworn on oath, depose and state as follows:

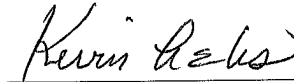
