## TRUSTEE WARRANTY DEED

For the consideration of Ten Dollar(s) and other valuable consideration, Bernard J. Monaghan and Margaret M. Monaghan, Trustees of the Bernard and Margaret Monaghan Revocable Trust Agreement dated February 12, 1993, do hereby Convey to John P. Monaghan and Polly A. Monaghan, as husband and wife as joint tenants with full rights of survivorship and not as tenants in common, the following described real estate in Delaware County, Iowa:

Southeast Quarter (SE¼) of the Southeast Quarter (SE¼) of Section Nineteen (19), Township Eighty Eight (88) North, Range Five (5), West of the 5th P.M., subject to easements of record; and all the North ¾ of the East ½ of Section Thirty (30), Township Eighty Eight (88) North, Range Five (5), West of the 5th P.M. lying East of the railroad right-of-way except the South 300 feet of the East 1000 feet of the Southeast Quarter (SE¼) of the Northeast Quarter (NE¼) and the North 200 feet of the East 1000 feet of the Northeast Quarter (NE¼) of the Southeast Quarter (SE¼) of said Section Thirty (30), Township Eighty Eight (88) North, Range Five (5), West of the 5th P.M. but including the following described real estate:

The West 200 feet of the East 971 feet of the South 155 feet of the Southeast Quarter (SE½) of the Northeast Quarter (NE½) and the West 200 feet of the East 971 feet of the North 32 feet of the Northeast Quarter (NE½) of the Southeast Quarter (SE½) all in Section Thirty (30), Township Eighty Eight (88) North, Range Five (5), West of the 5th P.M., subject to easements of records.
