QUIT CLAIM DEED

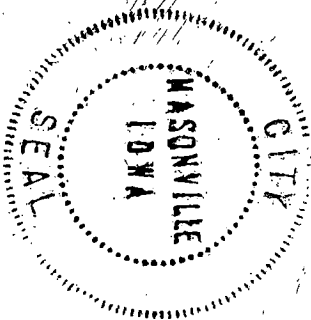
