QUIT CLAIM DEED

For the consideration of One Dollar(s) and other valuable consideration, City of Masonville, Iowa, an Iowa Municipal Corporation, organized and existing under the laws of Iowa, does hereby Convey to Mason T. Gallup and Cristen L. Gallup, husband and wife, as joint tenants with rights of survivorship and not as tenants in common all our right, title, interest, estate, claim and demand in the following described real estate in Delaware County, Iowa:

This deed is exempt according to Iowa Code 428A.2(21).

1. The North half of the portion of the alley lying South of and adjacent to Lot 201, Lot 202, Lot 203, Lot 204, Lot 205, Lot 206, Lot 207, Lot 208, Lot 209, the West half of the portion of Francis Street lying east of and adjacent to Lot 201, the West of half of the portion of Leonard Street adjacent to Lot 205 and the East half of the portion of Leonard Street adjacent to Lot 204, all in the City of Masonville, Iowa according to the plat recorded in Book 1 L.D., Page 134-135.
 - a. There shall be an easement for the property owner of Lot 235 for a three (3) foot radius around the existing building that is located partially on the West half of the portion of Leonard Street adjacent to Lot 234, in the City of Masonville, Iowa, according to the plat recorded in Book 1 L.D., Page 134-135.
2. The City of Masonville shall retain any and all existing easements for utilities, and necessary maintenance of said utilities.

Words and phrases herein, including acknowledgment hereof, shall be construed as in the singular or plural number, and as masculine or feminine gender, according to the context.
