## TAX SALE DEED

KNOW ALL PERSONS BY THESE PRESENTS,

that the following described parcel:

Lots sixty three (63) and sixty three and one-half (63 ½), Manchester, Iowa, according to Plat recorded in Book H, L.D., Pages 186-187,

situated in the County of Delaware, State of Iowa, was subject to taxes for the year 2019 (payable in 2020-21) and the taxes on the parcel for the year stated remained due and unpaid at the date of the sale; and the Treasurer of the County, on the 21st day of June, 2021, by virtue of the authority vested by law in the Treasurer at the sale begun and publicly held on the third Monday of June, 2021, exposed to public sale at the office of the County Treasurer in the county named, in substantial conformity with all the requirements of the statute, the parcel described, for the payment of the total amount then due and remaining unpaid on the parcel, and on the 21st of June, 2021, at Manchester, ACC 141 LLC offered to pay the sum of seven hundred forty-four dollars (\$744.00), being the total amount then due and remaining unpaid on the parcel for 100% which was the last quantity bid for, and payment of that sum was made by that person to the Treasurer, the parcel was stricken off to that person at that price.
