TOT Inspection Report Overall Narrative Comments: On May 15 2024 we did a septic inspection at 2557 240th ave Delhi, lowa 52223. We found the septic tank and started running water from a gardern hose at 3.92 gallons a minute. We started to look for distrubtion box which we located and dug up. Found it to plastic with 5 outlets and we probed and located a 30ft x 32ft bed syestem. the system was dry and had no ponding. We ran the hose for 70 mins and a load of 275 gallon of water. Then we pumped the septic tank and was a 1500 gallon 2 comartment tank with effulent filter on outlet pipe. The system was functioning as desgined at time of inspection.
