TRUSTEE WARRANTY DEED

For the consideration of One Dollar(s) and other valuable consideration, Jerome A. Krogmann and Rose A. Krogmann, Co-Trustees of the Jerome A. Krogmann and Rose A. Krogman Revocable Trust dated July 18, 2016, do hereby Convey to Joslyn N. Sailer, single person, the following described real estate in Delaware County, Iowa:

Lot 2 of Meadow Park Fourth Subdivision A Subdivision in part of the NE1/4-NW1/4 and in part of the NW1/4-NE1/4, Section 28, Township 89 North, Range 5 West of the 5th P.M., City of Manchester, Delaware County, Iowa, according to plat recorded in Book 2022, Page 873.

Words and phrases herein, including the acknowledgment hereof, shall be construed as in the singular or plural number, according to the context.

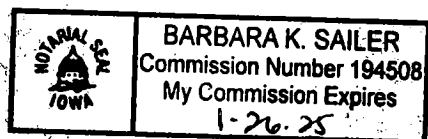
