RESOLUTION 2022-23 AMENDED

RESOLUTION DIRECTING THE SALE OF THE CITY'S INTEREST IN ALLEY AT 608 CHARLES STREET, DELHI, IOWA, DELAWARE COUNTY, IOWA

WHEREAS, the City is desirous of selling the real estate described herein.

WHEREAS, THE City Council has set forth its proposal to sell its interest in the above-described real estate and has published notice of the date, time and place of a public hearing thereon; and

WHEREAS, said public hearing was held and the City Council believes it is in the best interest of the City to sell the real estate in the above-described real estate on the terms and conditions set forth below;

BE IT RESOLVED by the Council of the City of Delhi, Iowa as follows:

SECTION 1. On behalf of the City, the Mayor shall contract to sell and shall convey by Quit Claim Deed the following described real estate:

That part of Alley located adjacent to Lots 6 and 7, Block 7 of Hobbs Addition to City of Delhi, Iowa, Delaware County, according to plat recorded in Book D L.D., Pages 516-517.

For the sum of \$3.00 per linear foot, with said property owner being solely responsible for the recording of the documents necessary to effectuate said transfer.

SECTION 2. The City Clerk shall co-sign such contracts and deeds. The Deed shall be delivered thirty days after the date of this Resolution, unless an appeal on this action has been made to District Court. Action on this Resolution shall be final upon the purchaser of the Deed giving evidence to the Clerk that the Deed has been recorded, and such facts to be noted on the official record of this Resolution.

SECTION 3. This resolution shall be in effect upon its passage and approval as provided by lat.
