

WARRANTY DEED



That part of the South one-half (S½) of the Southeast Quarter (SE¼) of the Northeast Quarter (NE¼) of Section Twenty Nine (29), Township Eighty Nine (89) North, Range Five (5), West of the Fifth P.M. described as commencing at a point on the South line of Clara Avenue two hundred sixty nine and fifteen one-hundredths (269.15) feet, West of the West line of New Street, thence South eighty five (85.0) feet, thence West ninety seven and fifteen one-hundredths (97.15) feet, thence North eighty five (85.0) feet, thence East ninety seven and fifteen one-hundredths (97.15) feet to the point of beginning.

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.
