AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

- I, Valda R. Schaul, being first duly sworn on oath, depose and state as follows:
- 1. Valda R. Schaul is the surviving spouse of LaVern V. Schaul, who died on October 3, 2024.
- 2. The following described real estate was owned only by LaVern V. Schaul and Valda R. Schaul, husband and wife, as joint tenants with full rights of survivorship at the time of LaVern V. Schaul's death:

Lots Four (4), Ten (10), and Elven (11) in the town of Masonville; also Five (5), except the North One (1) acre in the town of Masonville; also commencing at the Northeast (NE) corner of Lot Nine (9), Masonville, Iowa, and running thence South Three and Twenty-Six Hundredths (3.26) chains, thence West One and Six Tenths (1.6) chains, thence North Three and Twenty-Six Hundredths (3.26) chains, thence East One and Six Tenths (1.6) chains to beginning, same being a part of the Northeast Quarter (NE ¼) of Section Thirty-One (31), Township Eighty-Nine (89) North, Range Six (6) West of the Fifth P.M.
