PERMANENT CITY UTILITY EASEMENT

- ERECTION OF STRUCTURES PROHIBITED. Grantor shall not erect any landscaping or structure over or within the Easement Area without obtaining the prior written approval of the Grantee.
- 2. <u>CHANGE OF GRADE PROHIBITED</u>. Grantor shall not change the grade, elevation or contour of any part of the Easement Area without obtaining the prior written consent of the Grantee.
- 3. RIGHT OF ACCESS. The Grantee shall have the right of access to the Easement Area and have all rights of ingress and egress reasonably necessary for the use and enjoyment of the Easement Area as herein described, including but not limited to, the right to remove any unauthorized obstructions or structures placed or erected on the Easement Area.
- 4. <u>EASEMENT RUNS WITH LAND</u>. This Easement shall be deemed to run with the land and shall be binding on Grantor and on Grantor's successors and assigns.
