***This deed is exempt according to Iowa Code 428A.2(21).**



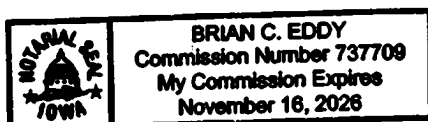
