Harbach and Barbara A. Harbach, husband and wife an undivided one half interest as joint tenants with full rights of survivorship and not as tenants in common; and James B. Harbach an undivided one half interest in, the following described real estate in Delaware County, Iowa:

Lot Five (5) of Harbach Subdivision A Subdivision In The NE¼ And In The NE¼ Of The SE¼ Section 14, T88N, R5W Of The Fifth P.M., Delaware County, Iowa, according to plat recorded in Book 20024, Page 562

AND

The grantor further warrants to the grantees all of the following: That the trust pursuant to which the transfer is made is duly executed and in existence; that to the knowledge of the grantor the person creating the trust was under no disability or infirmity at the time the trust was created; that the transfer by the trustee to the grantees is effective and rightful; and that the trustee knows of no facts or legal claims which might impair the validity of the trust or the validity of the transfer.
