

Whenever in the chain of title to the above-described property the names Lorraine Schuster and Lorraine E. Schuster, appear or occur, said names refer to one and the same person.

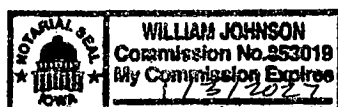
