AFFIDAVIT OF SURVIVING SPOUSE FOR CHANGE OF TITLE TO REAL ESTATE

- 1. I am the surviving spouse of Elizabeth J. Vaske, who died on July 20, 2024.
- 2. The following described real estate was owned only by Elizabeth J. Vaske and this Affiant, as joint tenants with full rights of survivorship at the time of Elizabeth J. Vaske's death:

That part of the Northwest Quarter (NW½) of the Southwest Quarter (SW½) of Section Thirty Three (33), Township Eighty Nine (89) North, Range Five (5), West of the Fifth Principal Meridian described as commencing at the Northeast corner of said Northwest Quarter (NW½) of the Southwest Quarter (SW½) and running thence West six and eighttenths (6.8) feet to the point of beginning, thence West six hundred sixty three and two-tenths (663.2) feet along the North line of said Northwest Quarter (NW¼) of the Southwest Quarter (SW¼), thence South one hundred fifty (150.0) feet, thence South 89° 55' East six hundred seventy and five-tenths (670.5) feet, thence Northerly one hundred fifty one and sixteen one-hundredths (151.16) feet along a one thousand nine hundred ten and eight one-hundredths (1910.08) foot radius curve concave Westerly to the point of beginning, excepting therefrom that part thereof conveyed to the City of Manchester by Special Warranty Deed recorded in Book 79, L.D., Page 113.
