WARRANTY DEED

For one dollar and other valuable consideration, GOOD NEIGHBOR SOCIETY, an Iowa not for profit corporation, as Grantor, does hereby convey to Kristin Miller as the Trustee(s) of the Paul F. Loecke and Arlene G. Loecke Irrevocable Trust, dated June 12, 2014, as Grantee, the following described real estate in Delaware County, Iowa:

A <u>life estate</u> in the Grantee for the life of <u>Paul Loecke</u> in Unit <u>15</u>, in Neighborhood Villas, A Condominium, Delaware County, Iowa, together with an undivided percentage interest in and to the common areas and facilities appurtenant thereto, all as appears of record in the Declaration recorded in the Office of the County Recorder, Delaware County, Iowa, on June 5, 2017, in Book 2017, beginning at Page 1549, as may be amended, with the remainder interest reserved to Good Neighbor Society, an Iowa not for profit corporation, following the expiration of the life estate or other termination of the interest of the Grantee in the above-described property.

Grantee may not sell or transfer its interest in the above-described property without the prior written consent of Grantor.

The Grantor hereby covenants with Grantee, and successors in interest, that it holds the real estate by title in fee simple; that it has good and lawful authority to sell and convey the real estate; that the real estate is free and clear of all liens and encumbrances, except as may be above stated; and it covenants to Warrant and Defend the real estate against the lawful claims of all persons, except as may be above stated. Each of the undersigned, if natural persons, hereby relinquishes all rights of dower, homestead and distributive share in and to the real estate.
