5. That the purpose of this Affidavit is to point out the scrivener's error in the county records to correct the above-referenced Quit Claim Deed.

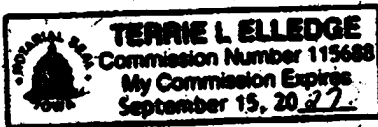
