### AGREEMENT FOR RELEASE OF LIABILITY

**THIS AGREEMENT**, dated as of the 5th day of September, 2025, by and between Fidelity Bank & Trust (hereinafter referred to as "FBT"), and Jordan G. Perrinjaquet and Jennifer M. Perrinjaquet, previously husband and wife (hereinafter collectively referred to "Jordan G. Perrinjaquet and Jennifer M. Perrinjaquet").

**WHEREAS**, FBT agreed to make and Jordan G. Perrinjaquet and Jennifer M. Perrinjaquet agreed to take, a mortgage loan of \$629,719.11; and

**WHEREAS**, to evidence its indebtedness for such loan, Jordan G. Perrinjaquet and Jennifer M. Perrinjaquet executed, issued and delivered to FBT their note, dated December, 16, 2022, in the original principal sum of \$629,719.11 (hereinafter referred to as the "Note"); and

**WHEREAS**, the Note and all of its terms are incorporated by reference into and secured by that certain mortgage dated the 16th day of December, 2022, and filed for record with the Recorder of Delaware County, Iowa, on the 19th day of December, 2022, as document no. BK: 2022 PG: 3687 (hereinafter referred to as the "Mortgage"); and

**WHEREAS**, the Mortgage affects the property described below located in Delaware County, Iowa (hereinafter referred to as the "Property") to wit:

**WHEREAS**, FBT is the owner and holder of the Note and Mortgage; and


**WHEREAS**, the Note is current with all required payments under the Mortgage having been paid; and


**WHEREAS**, the parties hereto mutually desire to modify and amend the Note and Mortgage, to release and discharge Jennifer M. Perrinjaquet from all personal obligation to FBT to pay the debt evidenced by said Note and Mortgage.

**NOW THEREFORE**, in consideration of the covenants contained herein and the mutual benefits to be derived therefrom, the parties hereto, for themselves and their respective heirs, executors, administrators, successors and assigns, hereby agree as follows:

1. FBT hereby consents to the release of Jennifer M. Perrinjaquet from all personal obligations to FBT as evidenced by said Note and Mortgage.
2. The Note and Mortgage are hereby modified and amended to remove Jennifer M. Perrinjaquet as an obligor thereunder.
3. Jordan G. Perrinjaquet agrees to pay said Note and Mortgage according to their original terms as modified herein and shall remain liable thereon to FBT in all respects.
4. FBT, in consideration of the agreements contained herein, hereby releases and discharges Jennifer M. Perrinjaquet from all personal obligation to FBT to pay the debt evidenced by said Note and Mortgage, it being the intent of this instrument that from the date hereof, Jennifer M. Perrinjaquet shall have no further or additional personal liability for the principal, interest, or other sums to be paid under the covenants contained in said Mortgage or Note; provided however, that nothing herein contained shall be deemed to be a release or impairment of the indebtedness secured by the Mortgage, the lien thereof or the obligations thereunder of Jordan G. Perrinjaquet, and FBT shall not be precluded from foreclosing said Mortgage in the event of any default thereunder by Jordan G. Perrinjaquet.
5. Save and except as modified herein, the terms and conditions of the Note and Mortgage remain in full force and effect.



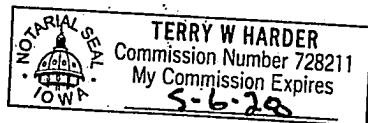

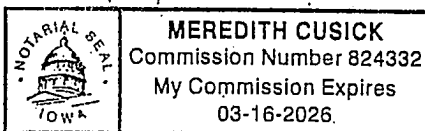
