Agreement for Land Acquisition Grand Avenue Street Extension Project

Whereas, the City of Manchester, Iowa is developing improvements known as the 2024 Grand Avenue Street Extension Project (the "Project"); and,

Whereas, detailed plans for construction of the Project have been prepared and made available for review by the parties to this agreement; and,

Whereas, the Delaware County Fair Society, Inc. is the owner of property specifically described on Exhibit A copy of which is attached hereto; and,

Whereas, subject to the terms and conditions set forth herein, to assist in the development of the property and the improvements anticipated by the Project, the Delaware County Fair Society, Inc. shall dedicate street, drainage, utility, and recreational right of way easements to the City of Manchester, Iowa for the real estate shown on Exhibit A.

Now therefore, the undersigned agree as follows:

- The Delaware County Fair Society, Inc. shall dedicate to the City of Manchester, Iowa an easement for street, drainage, utility, and recreational use as described on Exhibit A attached hereto.
- The City of Manchester, Iowa shall not, for a period of 25 years from the date of this agreement, charge or create any assessment to the Delaware County Fair Society, Inc., for street or sidewalk improvements placed upon the property described in Exhibit A attached hereto.
- 3. The City of Manchester, Iowa shall provide concrete driveways between the street and trail to the property line in the existing driveways as shown on Exhibit B.
- 4. The City of Manchester, Iowa shall be responsible for snow removal on the trail as shown on the plans for the Grand Avenue Trail Project and shall exercise reasonable care in snow removal so as not to damage fences owned by the Delaware County Fair Society, Inc.
- 5. The City of Manchester, Iowa shall provide appropriate lighting for the street anticipated by this agreement.
- 6. The City of Manchester, Iowa shall install a 4-inch water hook up in the street to allow water service directly west from the southeast corner of the Beef Barn.

- 7. The City of Manchester, Iowa shall replace or repair any fence located on property owned by the Delaware County Fair Society, Inc. that is altered or damaged due to construction of the street and trail improvements contemplated by the project.
- 8. The City of Manchester, Iowa shall install three utility hookups to Lot 2 as shown on Exhibit A.
- 9. Any crop damage to crops in 2024 located on land owned by the Delaware County Fair Society, Inc. resulting from construction of the improvements anticipated by the project shall be paid by the City of Manchester, Iowa.
- 10. The parties shall execute all documents necessary to give effect to the terms of this agreement.
