Delaware County, Iowa, according to plat recorded in Book 2020, Page 1311.

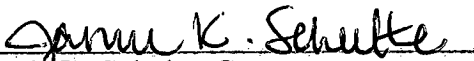

Words and phrases herein, including acknowledgment hereof, shall be construed as in the singular or plural number, and as masculine or feminine gender, according to the context.

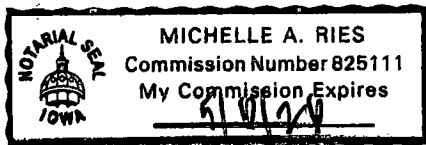

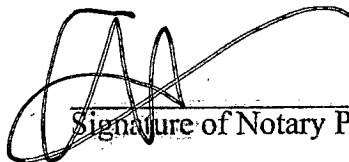
