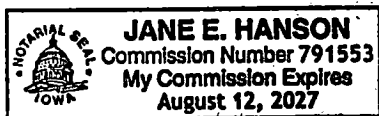


I, Daniel A. Schulte, being first duly sworn (or affirmed) under oath, state of my personal knowledge that:
