1. We are the Co-Trustees of Marjory J. Cortimiglia Revocable Trust Dated July 16, 2008, to which the above-described real estate was conveyed, pursuant to a Trustee Warranty Deed filed for record on July 25, 2008, in Book 2008, Page 2302 in the records of the Delaware County, Iowa Recorder.

2. We are presently the Co-Trustees of Marjory J. Cortimiglia Revocable Trust Dated July 16, 2008, and are authorized to execute and deliver a Trustee Warranty Deed conveying the above-described property to Stephen S. Piper and Janet E. Knott, without any limitation or qualification whatsoever.

3. The Trust is in existence and we, as Co-Trustees, are authorized to transfer the interest in the real estate as described above free and clear of any adverse claims.

4. Marjory J. Cortimiglia, died on September 21, 2025, and was the only living grantor and the sole beneficiary of the Trust at the time of her death. She was a single person at the time of her death.

5. Following the death of Marjory J. Cortimiglia, the only beneficiaries of the Trust were her lineal descendants. All of the beneficiaries were exempt individuals under Iowa Code §450.9. Therefore, there was no liability for Iowa inheritance taxes and pursuant to Iowa Code §450.22 an inheritance tax return was not required to be filed.



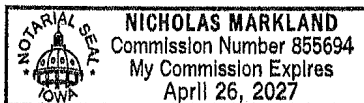
