Kramer Declaration of Trust dated February 5, 1997, does hereby Convey to KC Kramer, LLC, an Iowa limited liability company, the following described real estate in Delaware County, Iowa:

All that part of the Northeast Quarter (NE1/4) of Section Twenty Seven (27), Township Eighty Nine (89) North, Range Three (3), West of the Fifth Principal Meridian that lies South of the railroad right-of-way, except Parcel D Part Of The Southeast Quarter (SE1/4) Of The Northeast Quarter (NE1/4), Part Of The Southwest Quarter (SW1/4) Of The Northeast Quarter (NE1/4) And Part Of The Northwest Quarter (NW1/4) Of The Northeast Quarter (NE1/4) All In Section Twenty-Seven (27), Township Eighty-Nine North (T89N), Range Three West (R3W) Of The Fifth Principal Meridian, Delaware County, Iowa, according to plat recorded in Book 2005, Page 4210 and also except Parcel "E" Located In The Northeast Quarter Of Section 27, T89N, R3W Of The 5<sup>th</sup> P.M., Delaware County, Iowa, according to plat recorded in Book 2006, Page 3403

Words and phrases herein, including the acknowledgment hereof, shall be construed as in the singular or plural number, according to the context.

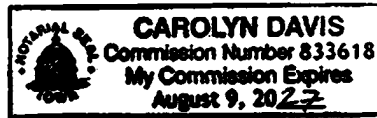


