TRUSTEE WARRANTY DEED

For the consideration of One Hundred Forty-Seven Thousand Dollar(s) and other valuable consideration, Jeffrey L. Manternach and Nancy J. Manternach as Co-Trustees of the Jeffrey L. Manternach Revocable Trust Dated June 7, 2023 as it may be amended from time to time, does hereby Convey to Jake Manternach and Lindsay J. Manternach, as a married couple as joint tenants with full rights of survivorship and not as tenants in common, the following described real estate in Delaware County, Iowa:

An undivided one-half interest in Parcel 2023-05, Part of the NW $\frac{1}{4}$ - NW $\frac{1}{4}$ and Parcel 2023-06, Part of the NW $\frac{1}{4}$ -NW $\frac{1}{4}$, Section 30, T89N, R6W of the 5th P.M., Delaware County, Iowa, according to plat recorded in Book 2023, Page 467; except the North two hundred thirty five (235) feet of the West two hundred twenty (220) feet of Parcel 2023-05 being part of the NW $\frac{1}{4}$ -NW $\frac{1}{4}$ Section 30, T89N, R6W of the 5th P.M., Delaware County, Iowa, according to plat recorded in Book 2023, Page 467

There is no known private burial site, well, solid waste disposal site, underground storage tank, hazardous waste, or private sewage disposal system on the property as described in Iowa Code Section 558.69, and therefore the transaction is exempt from the requirement to submit a groundwater hazard statement.

The grantor hereby covenants with grantees, and successors in interest, that grantor holds the real estate by title in fee simple; that grantor has good and lawful authority to sell and convey the real estate; that the real estate is free and clear of all liens and encumbrances, except as may be above stated; and grantor covenants to warrant and defend the real estate against the lawful claims of all persons, except as may be above stated.

The grantor further warrants to the grantees all of the following: That the trust pursuant to which the transfer is made is duly executed and in existence; that to the knowledge of the grantor the person creating the trust was under no disability or infirmity at the time the trust was created; that the transfer by the trustee to the grantees is effective and rightful; and that the trustee knows of no facts or legal claims which might impair the validity of the trust or the validity of the transfer.

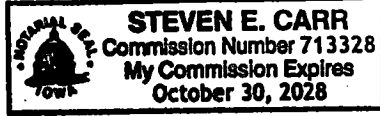

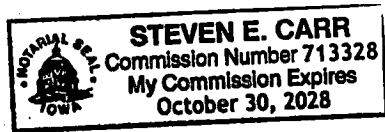
