In re: NE ¼ SW ¼ Sec 9, T89N R05W, Delaware Twp, Delaware County


This waiver of separation affecting the following described property in Delaware County, Delaware Township, legally described as: Located in the Vera's First Addition Pt, Lot 3 in SE ¼ SW ¼ Section 9, T89N R05W, Delaware Twp, Delaware County, Iowa, with 911 addresses of 1826 180th Street, Manchester, Iowa. Michael F. Loecke Revocable Trust & Megan A. Loecke Revocable Trust is titleholder to the above described property and have every legal authority to sign this separation distance waiver.

NE ¼ SW ¼ Section 9, T89N R5W, Delaware Twp, Delaware County, Iowa.


This site has an address 1766 180th Avenue, Delaware, Iowa and will be locally known as 5M Pork LLC. 5M Pork LLC plans to construct a deep pit formed manure structure with an animal unit capacity of 992 (2480 actual animal capacity) to add to our current animal unit capacity of 2480 head of hogs, making hits a 4960 head swine finishing unit. Pursuant to Iowa Code §459.202 (2007), a separation distance of 1875 feet is required between the formed manure structure and the undersigned's land where the residence is located. Pursuant to Iowa Code §459.205 (2)(2007), the undersigned as titleholder to the land where the residence is located hereby waives the enforcement of this separation distance requirement between the residence and this formed manure structure. This waiver shall apply only to the livestock facilities described in this agreement, it shall be perpetual and shall run with the land.

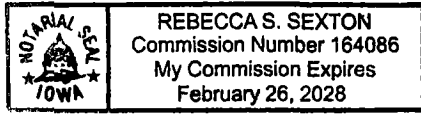

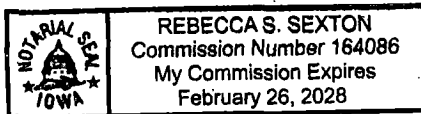
