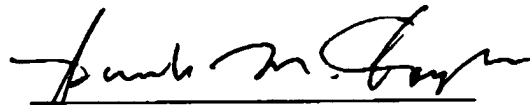
The N½ of the SW¼ of Section 6, Township 89 North, Range 6, West of the 5th P.M., Delaware County, Iowa.

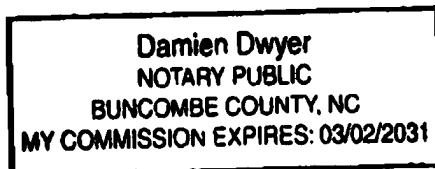

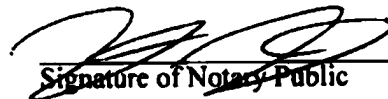

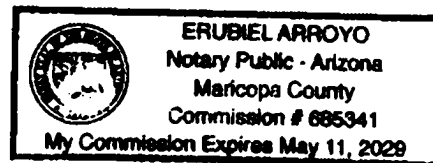
